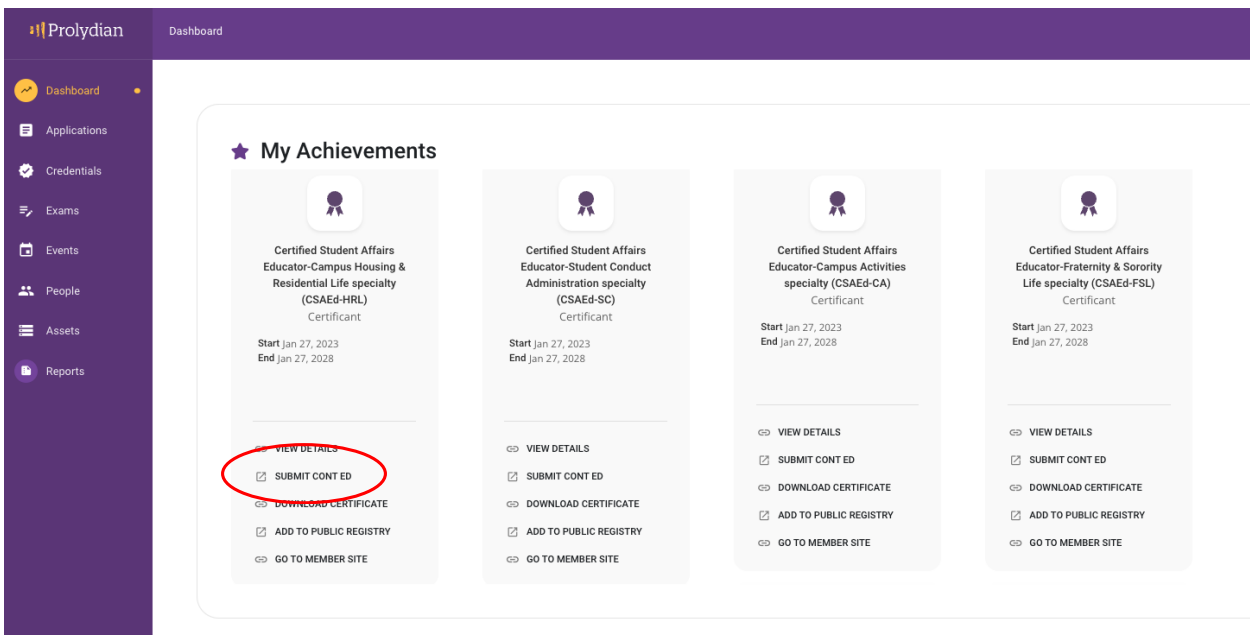


Appendix C: Submitting and Tracking Continuing Education Credits

This guide will assist you in searching for and submitting information about your completion of continuing education programs. For questions about available CE programs and the CE submission process, please reach out to ce@studentaffairscertification.org.

- Step 1:** Login to your [Prolydian account](#) online.
- On your “Dashboard,” find your certification credential for which you are wanting to apply your continuing education credits.¹ Beneath that credential, click “Submit Cont Ed.” (You can also find this by clicking on “Credentials” and “My Certifications.”)
 - This will open a screen that says “Continuing Education Activity” and “Request for Continuing Education Units.”



¹ If you attended a program where you received credits that apply toward more than one certification, you will need to complete this process an additional time for each certification the credits apply to.

Step 2: Find your approved CE program

- Enter the date (or one of the dates) that your continuing education program took place on.
- Make sure the button for **“I have a Preapproval Code (or want to look one up)”** is selected. (If you select “I want to enter the details of the activity” your submission will automatically be denied upon submission.)
- If you have a Preapproval Code (from the CE provider) you may enter it in the box to search. If you do not know the Preapproval Code, leave that field blank and click **“Advanced Search.”**

Step 3: Enter your completion details

- The information for the program you selected will automatically fill in for your CE submission. You will need to enter the number of credits you actually completed in that category in the “Activity Units” field. (This will auto-populate to the *maximum* number of credits of that category that you could have earned for this program. Please ensure you enter the number of credits you *actually* completed.)
- You will need to upload documentation with evidence that you completed this program and your listed number of credits. (The CE provider must provide you with documentation of completion.) Click “Choose files” under Documentation to upload your proof of completion. You will need to select a PDG, JPEG, or PNG file to upload.
- Once you have uploaded your Documentation, scroll down and click the purple “Submit” button. You will receive a pop-up message that your submission has been received.

Some CE programs will contain credits that count in multiple categories. For example, a large conference may contain credits in the Core category, the Social Justice & Inclusion category, and in one or more of the specialty categories. Within the Prolydian platform, the program will be listed separately in each of the categories for which it offers credit. A certificant who attended the conference would need to submit their completion separately for each category of CE offered.

As a reminder, a single credit cannot be applied toward a certificant's requirements in more than one category. For example, if a 1.0 credit session was approved for both Social Justice & Inclusion credit *and* Housing & Residential Life specialty credit, you would need to choose which category towards which you'd like to apply your completion of that credit. (You cannot "double-dip" and receive credit for two categories for a 1.0 credit program.)



Tracking Continuing Education Credits in Prolydian


For each certification you hold, under “view details,” you will see a certification dashboard that tracks your CE credit completion. This view includes how many credits you’ve completed so far with an indicator of how many more CE credits you need to complete before your recertification date to maintain your credential.

Below the dashboard is a listing of “My earned CE,” which should list your completed CE credits. If you do not see your submitted continuing education credits reflected in this dashboard, please reach out to ce@studentaffairscertification.org.
